With eager anticipation we look forward to the summer season תש"פ - 2020. Building on the reputation of summers past, we forge ahead to ensure that the upcoming camp experience will, אי"ה once again, exceed all expectations.

With much דשמיא Camp Malka has won acclaim as a model camp, where dynamic staff, stimulating שיעורים and thrilling activities combine to give our campers a most memorable summer!

Camp Malka upholds high standards which are carefully designed and monitored to cultivate a spiritually uplifting environment. Any material which can have an adverse effect on the purity of our campers is prohibited in camp, which includes, but is not limited to, secular books, music and magazines. We are all cognizant of the tremendous detriment that modern technology imposes on our children, and, as such, no cell phones, DVD players, ipods or MP3 players will be permitted. These rules will be strictly enforced with a zero tolerance policy.

Camp Malka takes pride in the sensitivity and refined dress displayed by its campers and staff members. Following are the guidelines we have implemented to foster an atmosphere of modesty and *kedusha*.

- All socks must be at least knee length, even when worn with a long skirt.
- Hemlines of skirts should extend **substantially** below the knees. **Please pay particular attention to this point.**
- Skirts must not be longer than ankle length.
- Special attention must be given to ensure that skirts made of slinky material not be form fitting.
- Slits, back pockets, or zipper fronts on skirts are not allowed.
- Shirts must be cut generously and long enough to cover even when bending and raising ones arms.
- Sleeves must be long enough to cover the elbows completely, even when reaching or playing.
- The necklines on all blouses and shirts must be high enough to cover up until the neck. V-neck tops or any other tops that have wide necklines may not be worn without a shell underneath. Crew neck shirts should be carefully examined to make sure that they cover properly.
- Tight fitting clothing is never permitted.
- All sleepwear must provide proper coverage of the elbows and knees.
- Nail polish is not permitted to be worn or brought to camp.

- Refined jewelry is perfectly acceptable. However, earrings that dangle far from the ear or large hoops should not be worn.
- Robes worn to the pool should offer proper coverage.
- Only one piece bathing suits are allowed.

We strongly encourage simplicity when selecting your daughter's wardrobe. With a unified mission we will be"n see much *nachas* from our girls as they mature and develop into *bnos chayil*.

**Responses will be mailed at the end of December/ beginning of January, as priority is given to former campers.**

We look forward to greeting our girls as they partner with us in perpetuating the meaningful tradition that is Camp Malka!

We will make every effort to protect the personal belongings of every camper. However, the camp is not responsible or liable for equipment or personal property (including money or jewelry) of any camper - while in transit or at camp - whether the equipment or personal property is lost, stolen, or damaged by fire, laundering, or other cause.

Please be sure to complete all sections of this application including trip preference box. **Please note: if any part of this application is not complete, it will be returned to you, and registration will be delayed until a complete application is received.**

### Payment Information:

Half a summer for Regular Camper (completing grades 5,6,7,8): \$2,475

Half a summer for CITs (completing grade 9) \$2,525

Half a summer for TC Program (completing grade 10): \$2,595

I hereby apply to enroll my daughter in Camp Malka for the upcoming summer season. I have enclosed a check, an ACH Authorization Agreement, or provided credit card info for a deposit of \$750 per trip. For payment of the balance, I am including post-dated checks, or, you may debit money from my account or charge my credit card, as indicated. **No application will be processed without a deposit and the arrangements for the remaining balance, in the form of a credit card, ACH agreement or head checks.** The deposit is refundable until January 31<sup>st</sup>. (minus a processing fee of \$150). If my daughter is not accepted, the entire deposit will be refunded. I understand that this application is subject to review and approval.

\_\_\_\_\_ The balance is enclosed in the form of post-dated checks. The balance must be paid in full by May 11<sup>th</sup>. (If you wish to issue new checks, the checks must be received two weeks in advance of the payment due date, otherwise, the original check will be cashed.) **All checks must have the camper's name on it so the correct account will be credited.**

\_\_\_\_\_ I have filled out the ACH processing agreement and I understand that the balance will be debited from my account in 2 installments: the first on March 2<sup>nd</sup> and the second on May 11<sup>th</sup>.

**We will not contact you prior to depositing your check or charging your credit card. Any changes to payment method must be called in to the business office at least 2 weeks in advance of the payment due date.**

**Please make checks payable to Camp Malka.** There will be a \$35.00 charge for returned checks.

The camp fee includes all regular camp activities and laundry, but **does not include off-site medical expenses, tips, canteen, luggage/ transportation, or visiting day transportation.**

### 1) Refund policy:

Any cancellation, even partial, prior to **January 31<sup>st</sup>** will incur a service fee of \$150.00. No refunds will be made after **January 31<sup>st</sup>**, and cancellations after that date will result in a forfeiture of all funds paid.

Due to the seasonal nature of summer camp and the limited space available, we will not remunerate for late arrival, early departure, or absence, including early dismissal of a camper by the administration.

It is understood and agreed that, if a camper leaves camp grounds without permission of the Camp Director, or, if a camper damages or defaces camp property, or if a camper's conduct is not up to the camp's standards, the camper will be dismissed at the sole discretion of the Director with no monetary remuneration.

### 2) Permission to Leave Camp Grounds:

I permit my daughter to leave camp grounds, when applicable, for the purpose of participating in camp programs such as, but not limited to, inter-camp games and trips.

### 3) Medical Authorization and Parental Consent:

In the event of accident, illness, medical or surgical emergency, I hereby authorize the Camp Director, Doctor, Nurse, or any administrative personnel, if unable to contact me, to act for me according to their best judgment with respect to the care of my daughter \_\_\_\_\_, including any medical and surgical care. I understand that every effort will be made by the camp administration to contact me immediately in the event of an emergency. I hereby release Camp Malka and all persons connected therein from any and all liability and responsibility in the performance of the above acts and medical services. **I understand that I am financially responsible for all costs and expenses which are not covered by my medical insurance.**

Medical services are provided through the camp infirmary and camp nurses. Off-site medical services and medications deemed necessary by the camp medical staff, or by the parents, shall remain the responsibility of the parents.
